

MACRO

- US equities were slightly lower in reasonably quiet Columbus Day trading.
- The Dow fell 29.23 points to 26,787.36, the S& P 500 lost 4.12 points to 2,966.15, while the Nasdaq slipped 8.39 points to 8,048.65.
- Materials (-0.74%) and utilities (-0.67%) led the losses.
- The VIX gauge lost 6.48% to 14.57.
- Quiet session for currency majors, the US dollar index was flat at 98.43,
- European shares were lower, the EuroSTOXX shed 0.49%, the German DAX declined 0.20%, while the UK FTSE lost 0.46%.
- Oil prices were lower, Brent sold off 1.6% to \$59.21 while WTI fell 1.7% to \$53.47.
- Base metals were mixed, with nickel (-5.7%) taking the biggest hit.

PRECIOUS

- Gold was sold to the days low \$1482 in early Asian trading.
- The onshore SGE premium was around \$6-7.

- Gold made a slow rise back to opening levels through remaining Asian hours.
- The metal gapped \$5 higher to \$1495 during the London AM session before posting the \$1496 high.
- NY were on the offer early and sold the metal back to \$1488.
- Remaining NY hours were fairly quiet before the yellow metal closed at \$1492.
- Silver finished up near the highs at \$17.64.
- Palladium rose to a fresh record \$1720.
- The Philadelphia gold and silver index rose 0.42%.
- SPDR Gold Trust holdings were unchanged at 921.71mt.
