## **MACRO**

- The Dow staged a remarkable recovery in late trade, recovering an astounding 900 points to close on the highs.
- The Dow gained 260.37 points, the S&P500 climbed 21.13 points whilst the Nasdaq rallied 25.14 points.
- European shares were lower. Euro STOXX fell 1.22%, the FTSE lost 1.52% whilst the German Dax retreated 2.37%.
- The VIX was 0.45 points lower to 29.96.
- The US 10 year yield gained 0.0071 bps to 2.7738% whilst the 2 year yield rose 0.0061 bps to 2.5686%
- Oil prices were firmer. WTI rose \$1.48 to \$46.08.
- The CRB index fell 1.42% to 170.48.
- Base metals were mixed with aluminium the standout, up 1.05%

## **PRECIOUS**

- Another choppy session for the precious.
- Asia started the day with a bid after the vicious sell off late in the session in NY.
- XAU rallied up to 1272 before profit taking emerged.
- SGE premium around \$7 over loco London.
- London were early sellers pressuring gold down to 1268, but heavy bids on the downside provided support and the yellow metal started to squeeze higher back above 1270.
- NY were also buyers pushing XAU up to 1278.55 before selling emerged on the back of the soaring equities into the NY close.
- Silver performed well rallying to a high of 15.25
- The Philadelphia gold and silver index rose 0.81%.
- The SPDR gold trust holdings fell 0.3% to 787.67.
